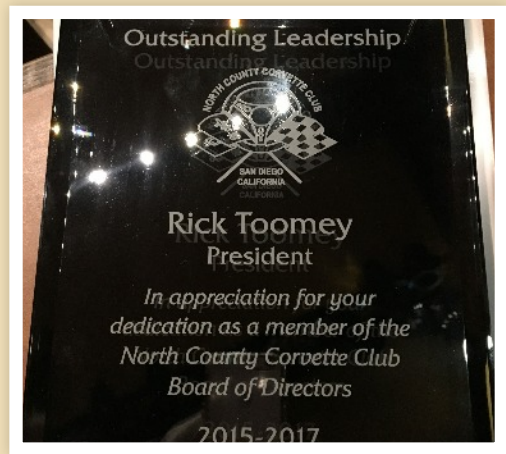

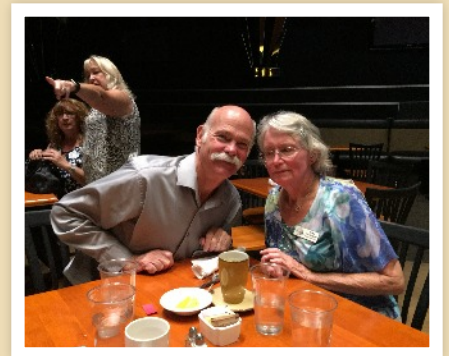

My Auto Body and Paint Experience

I want to share my experiences with ACM Auto body and Paint. This is a general auto body repair shop that Jack used and promoted for years in Escondido. It's owned and run by Ramon Gonzalez and his, 20 something year old, son. Our 2013 Grand Sport has needed body work and paint 3 times since we've owned it:

- 1) Cracked rear fender due to my poor driving skills.
- 2) Rear panel gouged due to closing the garage door on it.
- 3) Repair after my son drove it over a curb resulting in re-cracking the rear fender, cracking the front nose piece and scratching the full length of the drivers side heavily. In addition, the tow truck driver left us with a punctured hood.

No job is too small for him to do. He repaired the rear fender for \$700.00. I had received quotes of up to \$6000 for the same job. He's an old fashion body guy who fixes rather than replace if he can. I like that. He tells you how it will be before he does the job, meaning if there is something that won't be perfect, he'll let you know. He brought in a specialist from the paint company to help match the metallic cyber gray on the car. All paint he's done matches perfectly.

He covers the car perfectly when it's in the booth to ensure no over spray. He does a terrific job at masking and covering. When the car is done, it's returned clean and tidy inside and out. Ramon doesn't take in more work than he can do that week. The first Monday morning I arrived, his shop was empty and waiting for the car.

He inspects the car with you and, if something isn't right, he'll make sure it is before he releases the car. I've become so comfortable with his fairness that the 3rd time I dropped off my car, I didn't ask for an estimate. Just take care of it I told him. Boy was he fair on price with me. Absolutely no complaints from me on price or quality of work. He works with all insurance companies, though I paid each time directly. Check out the car next time you see it and see how it looks to you. He can be reached at (760) 747-1628.

Send him a picture of what you need and he can give you an estimate over email. Appointments only to have the work done. Needless to say, I have my own file with paint codes and notes in his system. I always say to him as I'm leaving, "see you next time". Did I mention that I have a body shop as a tenant? I prefer Ramon.
